Changes at TSCRA Top Executive Position

TSCRA announced on April 17 a major staffing change with the expected retirement of current Executive Vice President and CEO Eldon White. Succeeding White will be TSCRA Executive Director of Government and Public Affairs, Jason Skaggs.

White announced his planned retirement to the TSCRA Executive Committee during the 2018 Cattle Raisers Convention and Expo in late March. He will step aside on Sept. 1, 2018, after which time he will continue to serve as executive vice president emeritus until his official retirement on Dec. 31, 2018, to aid in a smooth transition.

White joined TSCRA as executive vice president and CEO

in May 2007. Throughout his 11-year tenure, he has been an asset to the association and cattle industry.

Skaggs will take over the position on Sept. 1, 2018. For the past decade, Skaggs has led the TSCRA Government and Public Affairs office in Austin, where he earned the respect of legislators and others in the government affairs arena, as well as TSCRA members and leaders.

BQA Tip for May: Bull Management

Bull management is critical for high pregnancy rates. Prior to the breeding season, always commingle bulls that will be used together in multiple-sire groups. This will reduce fighting and potential injuries. Groups should consist of bulls that are similar in size and age. After bulls are turned out with cows, watch to make sure that all the bulls are actively checking and breeding cows. If a bull is off by himself, it may indicate that something is wrong, and he should be checked for injuries, foot rot, or other potential problems.

Suspect Surrenders in Million-Dollar Embezzlement Case

On April 12, 2018, Marty Robert Maahs, 33, turned himself in to the Jackson County Sheriff's Department. A warrant had been issued for his arrest as the result of an investigation by TSCRA Special Ranger Scott Williamson.

Williamson initiated an investigation in early 2017, after being contacted by Frazer Bank in Altus. Bank officials were concerned about possible illicit activities by Maahs in connection with a bank loan valued at more than \$1 million, in which he put up cattle as collateral. Through the course of the investigation, Williamson discovered that Maahs had disposed of livestock proceeds without payment to the bank. The investigation also revealed embezzlement of livestock funds, false statement and representation of collateral to the bank, and the sale of mortgaged personal property without payment to the bank.

The investigation led to three felony counts: embezzlement greater than \$25,000, obtaining by trick or deception greater than \$1,000, and chattel encumbered greater than \$1,000. The three charges could land Maahs in prison for up to 23 years. He also faces possible fines of more than \$15,000 and restitution to the bank exceeding \$1 million.

Maahs was booked into the Jackson County Jail after his surrender. He was released on bond and is awaiting trial.

Information Sought, Reward Offered for Stolen Sheep

TSCRA Special Ranger Kenny Wadsworth is seeking information after approximately 125 head of Dorper sheep were stolen from a Crockett County ranch in West Texas sometime between March 14 and 28.

A cash reward of up to \$2,500 is offered for information leading to the recovery of the animals and/or arrest of the persons responsible. The total includes up to \$1,000 from Operation Cow Thief, an anti-theft initiative led by TSCRA, \$1,000 from the victim and another \$500 from Crockett County.
