Health Insurance Open Enrollment Ends Jan. 31




PEN ENROLLMENT FOR INDIVIDUAL MEDICAL POLICYHOLDERS ENDS in just a few short days on Jan. 31, 2016. The Cattle Raisers Insurance team is here to guide you through the open enrollment process and answer all of your questions.

After Jan. 31, the Affordable Care Act will not allow you to make any changes to your health care insurance plan until the next open enrollment period begins on Oct. 1, 2016, and closes Dec. 15, 2016. However, if you have a "qualifying event" between Jan. 31 and Oct. 1, then you will be eligible to change your health care insurance coverage. Congress Repeals COOL Meat Label Rules

AWMAKERS PASSED IN DECEMBER THE FISCAL YEAR 2016 OMNIBUS APPROPRIATIONS ACT, H.R. 2029 THAT CON-Itained language to repeal the country-of-origin labeling (COOL) requirements for muscle cuts of beef and pork, and ground beef and pork. Effective immediately, USDA is not enforcing the COOL requirements for muscle cut and ground beef and pork outlined in the January 2009 and May 2013 final rules.

USDA will be amending the COOL regulations as expeditiously as possible to reflect the repeal of the beef and pork provisions. In addition, all imported and domestic meat will continue to be subject to rigorous inspections by USDA to ensure food safety.



"Repealing COOL will benefit ranchers by preventing the imminent threat of more than \$1 billion in tariffs from being implemented by Canada and Mexico, two of our largest trading partners," said TSCRA President Pete Bonds. "We appreciate Senator John Cornyn and House Committee on Agriculture Chairman Mike Conaway for their tireless efforts to repeal COOL."

BQA Tip of the Month: The Right Dose for the Right Weight

WHEN ADMINISTERING antibiotics, make sure to calculate the proper dose based on the weight of the animal. Under dosing will likely reduce product efficacy and over-dosing increases withdrawal time and cost.



If individual animals are treated with antibiotics, they should also be individually identified and procedures put in place to prevent marketing before withdrawal times listed on the label are complete, or as recommended by your veterinarian.
