Bonds Receives W.A. "Bill" King Award

TSCRA Past President, rancher, businessman and beef industry leader Pete Bonds, Saginaw, received the 2017 W.A. "Bill" King Award for excellence in agriculture on Thursday, Jan. 19. The award was given at the Fort Worth Stock Show & Rodeo's Livestock Appreciation Luncheon in Fort Worth, presented by Lone Star Ag Credit.

"Pete Bonds has reached the pinnacle of ranching in North America," said Jessica Birge, president of the Fort Worth Farm and Ranch Club. "We're delighted to honor this industry icon with the Bill King Award."

Bonds served as TSCRA president from 2013 to 2016. He has ranched his entire life and operates the Bonds Ranch in Saginaw, where he also lives. He and his wife, Jo, have 3 daughters, Missy, Bonnie and April.

The W.A. "Bill" King Award recognizes a business, individual or family which has significantly contributed to agriculture or the agribusiness industry. King founded the Fort Worth Farm and Ranch Club in 1950 and served as the Stock Show's livestock show manager from 1947 to 1977.

BQATip: Needle Selection Basics

Proper needle selection is important for reducing the risk of broken needles and it makes the process of giving injections easier. Both needle length

and gauge should be considered. Shorter needles (i.e. 5/8 and 3/4) make it easier to properly give subcutaneous injections. For intramuscular injections, a 1-inch long needle is sufficient even on bulls and cows; using a longer needle increases the risk of the needle bending and/or breaking.



For thicker products, a 16-gauge needle works well. Either a 16 or 18-gauge needle is fine for thinner products. Avoid needles that are less than 18-gauge when giving injections to cattle.

Tennessee Man Arrested, Charged With 18 Counts of Theft

A Hendersonville, Tenn., man was arrested Jan. 13 and charged with 18 counts of theft in a case that involves victims across the U.S., including Blanco, Texas. Timothy Michael Evans, 50, is accused of selling electronic cattle ear tags and not delivering the product.

TSCRA Special Ranger Mike Barr led the investigation with assistance from Special Ranger Wayne Goodman and Hendersonville Sheriff's Department Detective Sgt. Jim Vaughn.

According to Barr, the suspect made up a company called Cattle Traxx and used a website and social media to fraudulently sell electronic ear tags to a victim in Blanco, Texas. The victim said he never

An investigation revealed that Evans made up the fake company and charged 29 victims for ear tags but never planned to deliver the product. The ear tags Evans promoted never existed. The suspect also scammed multiple news publications by failing to pay invoices for advertisements he placed to

Barr worked with Vaughn to locate Evans by tracking the suspect's computer IP address. Vaughn arrested Evans January 13, and the suspect was charged with 14 counts of theft over \$1,000 and four counts of theft over \$10,000. Evans is currently being held in the Summer County, Tennessee, Jail on a \$10,000 bond. The suspect has a criminal court date set for Jan. 20, 2017.
