# **TSCRA Testifies Before State Committee on Landowner Rights**

Lamber May 20 regarding S.B. 474 in a House Land and Resource Management Committee Hearing at the Texas State Capitol. The bill is authored by state Senator Lois Kolkhorst, Dist. 18 - Brenham, and Representative Cindy Burkett, Dist. 113 - Garland.

In Kinsel's remarks to the committee members, she spoke about her first-hand experiences of dealing with the condemnation process and how costly litigation can be. She discussed how S.B. 474 would help level the playing field for landowners by requiring condemnors to pay the costs and fees incurred by landowners if the amount of damages awarded to the landowner is at least 20 percent greater than the initial amount the condemnor offered to pay.

# Fairfax Man Sentenced to 10 Years in Prison for Cattle Theft

CARRETT MITCHELL GIBSON, 27, OF FAIRFAX, Okla., was convicted and sentenced to 10 years in prison on May 6 after pleading guilty to stealing 7 head of cattle from the Bledsoe Ranch near Ralston,



Okla., in 2014. TSCRA Special Ranger Bart Perrier led the investigation with TSCRA Special Ranger John Cummings and Osage County Sheriff's Office Investigator Doug Elliot assisting.

According to Perrier, Gibson stole a total of 7 head of cows from the ranch on 3 occasions. The investigation revealed that the cattle were sold at 3 livestock markets in north Central Oklahoma. After the sales, the cattle had been transported out of the area and could not be recovered.

Gibson pleaded guilty to larceny of livestock and was ordered to serve at least 2 years in the Oklahoma Department of Corrections, with the remainder of the time served on probation. He is also required to pay \$20,000 in restitution.

"This case is a great example of TSCRA special rangers working with local authorities to seek justice for ranchers who have unfortunately been victims of cattle theft," said Perrier. "I encourage all ranchers to always brand and keep a close watch on their cattle. These precautions serve as the best defense against cattle theft."
