## **2016 YCC Hits the Nation's Capitol**



Participants in this year's Young Cattlemen's Conference topped off their week-long traveling conference with two days of meetings in Wash-

ington D.C. Attendees met with Congressional leaders and staff to discuss issues important to cattle raisers and visited historic locations around the city.

Earlier in the week, the conference visited National Cattlemen's Beef Association headquarters, CattleFax offices, and JBS Kuner River Feedyard and Greeley facility in Colorado. They also took a tour of the Chicago Board of Trade and OSI, Inc., in Chicago.

Each year, TSCRA sends representatives on the YCC trip. Representatives are chosen by an application and interview process. Applications are available on January 31 and due on March 1 of each year.

### **TSCRA Testifies Before Texas House Ag and Livestock Committee**

Jason Skaggs, TSCRA executive director of government and public affairs, testified May 23 before the Texas House Agriculture and Livestock Committee at an interim hearing at the State Capitol. TSCRA was invited to testify specifically on the committee's interim charge of evaluating challenges and threats to the Texas cattle industry.

Skaggs discussed the current state of the cattle industry and spoke about the importance of conserving the state's water resources. He also discussed what TSCRA has done to help with the state's preparedness for natural disasters and disease outbreaks. Lastly, Skaggs talked about the importance

of preserving land for agricultural use, and the possible effects of oil and gas production that declining oil and gas prices could have on surface damages to ranchers' property.



# **BQA** Tip of the **Month: Follow Label Instructions for Injected Medicines**

When it comes to using injected medications in your cattle herd health program, follow the product label recommendations for injection sites. Using more than the rec-



ommended amount can reduce how well the product works and can increase withdrawal times. If the label doesn't specify an amount, then a good guideline is to use a maximum of 10 mL per injection site. For example, if the dose is 60 mL, then that amount should be divided into 6 locations, spaced at least 3 to 4 inches apart.

## **Burlington Man Sentenced** to 15 Years in Prison for Cattle Theft

A Milam County judge sentenced William James Crenan, 59, of Burlington, Texas, to 15 years in prison on May 25 in the case of more than 100 head of cattle stolen from an El Paso rancher. Crenan was also ordered to pay



\$575,922 in restitution to the victim.

TSCRA Special Rangers Marvin Wills and Hal Dumas led the investigation in cooperation with the Milam County Sheriff's Office. The victim had been running cattle on Crenan's pasture in northern Milam County.

The theft occurred on or around May 14, 2013. On May 6, 2016, the defendant was found guilty of theft of \$100,000 to \$200,000 from an elderly person, which is a first-degree felony. The weeklong jury trial was held in the 20th District Court in Cameron, with Judge John Youngblood presiding. John Graves Redington, Milam County Assistant County and District Attorney, prosecuted the case for the state and was very pleased with the outcome.
