Hunters Reminded of South Texas Fever Tick Quarantines

Texas Animal Health Commission (TAHC) and USDA Veterinary Services (VS) officials are reminding hunters in South Texas that additional precautions are required when handling white-tailed deer, nilgai antelope, black buck, axis deer, and other exotics located on fever tick quarantined premises.

Portions of Cameron, Hidalgo, Jim Wells, Kinney, Kleberg, Live Oak, Maverick, Starr, Webb, Willacy and Zapata counties have established fever tick quarantine areas and 37 additional Texas counties have individual premises quarantined.

Landowners, lessees, or other individuals who plan to harvest, move or capture white-tailed deer, nilgai antelope, or other exotic animals located on an infested, exposed, adjacent, or check quarantined premises must have the animals inspected and treated by a TAHC or USDA-VS representative before moving off the premises.

The inspection and treatment process is fairly quick and simple. Hunters must notify their TAHC region office or a USDA-VS representative after harvesting an animal and before movement, so the hides can be inspected and treated. All inspected hides, capes, and animals will be issued a movement permit after treatment and the movement permit must accompany the animal or animal parts at all times.

If hunting in Cameron, Hidalgo, Kinney, Maverick, Starr, Webb, Willacy or Zapata counties, and unsure of the premises quarantine status, contact the TAHC Region 8 office at 956-568-5741 or the premises USDA CFTEP county office at offices.sc.egov.usda.gov/locator/app. If hunting in Live Oak, Jim Wells or Kleberg counties, contact the TAHC Region 5 office at 361-358-3234.

BQA Tip of the Month: Time to Treat for Cattle Lice

Late fall and early winter are good times to treat cattle for lice. All cattle in the herd should be treated or re-infestation from non-treated animals will occur. Treatment protocols will vary depending on the product being used. Injectable dewormers generally only get sucking lice, but pour-on products can control both biting and sucking lice. Traditional permethrin-based pour-on products require 2 treatments: an initial treatment followed by a second treatment in 2 to 3 weeks to break the life cycle.

String of Central Texas Burglaries Lands Duo in Jail

Billy Tate Shoaf, 35, and Ashely Nicole Mitchell, 24, both of Gatesville, were arrested last month in connection to a string of rural Central Texas burglaries and thefts. TSCRA Special Ranger Marvin Wills led the investigation.



Wills received information that connected Shoaf to a burglary in Bosque County and contacted the Bosque County Sheriff's Department to secure an arrest warrant. Shoaf was apprehended at his residence in Gatesville without incident in September. Mitchell, his reported girlfriend, was also arrested at that time.

Following the arrests, the Coryell County Sheriff's Department executed search warrants for the suspects' residence and a storage unit, where a considerable number of stolen items were found, including an all-terrain vehicle (ATV). The search at Shoaf's residence also turned up illegal drugs and drug paraphernalia.

The pair is alleged to have targeted mainly rural properties and hunting camps, and authorities are holding several ATVs and other items that are suspected of being stolen. Arrests Made in Hopkins County Cattle Theft

Landon Dee Harness, 22, and Lane Wesley Keller, 21, both of Sulphur Springs, were arrested last month on charges of Theft of Livestock. The charges and arrest are the result of an investigation conducted by TSCRA Special Ranger Toney Hurley and local investigators.



The investigation is ongoing and

additional charges may be added as investigators determine whether the pair were involved in other unsolved cattle thefts in the area. Hurley is also working with Oklahoma officials to recover the stolen cattle and return them to their rightful owner.
