# Williamson Named to Top TSCRA Law Enforcement Spot

Texas and Southwestern Cattle Raisers Association (TSCRA)) has named Scott Williamson executive of law enforcement effective June 1. He takes the position vacated by Larry Gray, who retired after 37 years of distinguished service.

Williamson has served TSCRA for more than 31 years, where he started as a brand inspector in 1987. He was later commissioned as a special ranger and held that position for more than 23 years with dual commission by the Texas Department of Public Safety (DPS) and Oklahoma State Bureau of Investigation (OSBI). He also served as regional supervisor over 77 counties in Oklahoma and Texas.

Williamson has established himself as a leader within the law enforcement community, maintaining close relationships with the DPS, OSBI and many other national, state and local law enforcement agencies. Williamson has served as the president for both the International Livestock Identification Association and the Western States Livestock Investigators Association, and currently serves on the Joint Terrorism Task Force headed by the Department of Homeland Security and FBI. He is also well versed in emergency management and most recently aided in disaster recovery efforts following Hurricane Harvey. John Bradshaw, an 18-year TSCRA veteran from District 8 in Northwest Texas, will fill the regional supervisory position vacated by Williamson's promotion. Gary Baros will take over as supervisor in far South Texas with the retirement of Sonny Seewald.

In all, TSCRA has 30 special rangers stationed throughout Texas and Oklahoma. An elite group of law enforcement officers, TSCRA special rangers have extensive knowledge of the cattle industry and primarily investigate cattle theft and other agricultural crimes, though they are well-trained in all facets of law enforcement.

### **BQA Tip: Managing Stocking Rates**

It is tempting to increase cow-calf numbers to take advantage of surplus forage that abounds in early summer. However, if ranches are stocked to utilize all the forage at peak production, it means that the rest of the year the property is overstocked. When managing stocking rates, keep forage production patterns in mind so that stocking



rates are appropriate throughout the year. It is also worth considering to stock at 80 percent, or a level below maximum capacity, to allow for drought and any adverse weather conditions.

#### **Sentence Handed Down in 2016 Cattle Theft**

Jeremie Del Ral Ford, 30, was sentenced to 12 years in prison and ordered to pay more than \$4,000 in restitution following a May conviction on charges of theft of livestock. The charges were the result of an investigation led by Texas and Southwestern Cattle Raisers Association (TSCRA) Special Ranger Larry Hand. Hand was assisted in the investigation by TSCRA Special Ranger Jimmy Dickson and the Smith County Sheriff's Office.

The case involved 3 cows that were reported stolen from a ranch in eastern Smith County in October 2016. TSCRA special rangers located 2 of the animals, which had been sold at a local livestock auction. The seller was identified as Ford. Hand also recovered a feed sack at the crime scene that he traced to a feed store in Arp, which provided an invoice further linking Ford to the crime. It is believed he used the feed to entice the cattle and facilitate their removal from the pasture.

With substantial evidence connecting Ford to the theft, a felony arrest warrant was issued by a Smith County judge. Ford was arrested by the Kilgore Police Department on Feb. 24, 2017, and later transferred to the Smith County Jail where he was arraigned on March 2, 2017. Ford was subsequently convicted of theft of livestock less than \$150,000 by a Smith County jury on May 3, 2018. He remained in custody on a \$300,000 bond until the sentencing.

Hand believes additional suspects may be involved with the theft, but authorities have not yet obtained enough evidence to bring charges.
