Following the conclusion of the camps, participants are encouraged to attend a minimum of one TSCRA Ranch Gathering within the 2025 calendar year and will receive a complimentary registration to attend the 2026 Cattle Raisers Convention & Expo.

### **Leadership Launch Information**

TSCRA Leadership Launch is a two-day experience for incoming juniors and seniors in high school. Attendees will have the opportunity to visit industry leaders, gain an understanding of the legislative process and develop their professional skills. The program is intended for young professionals who are interested in gaining knowledge on private property rights, natural resources or policy affecting the beef industry. Applicants not selected are encouraged, if age applicable, to reapply.

#### **Objectives**

- Introduce participants to the policy process, state agencies and elected officials.
- Allow participants to meet and interact with leading industry representatives, TSCRA board and committee members.
- Create a networking opportunity of likeminded young professionals in the beef industry.

### Crite<u>ria</u>

- Individuals will be starting their junior or senior year of high school in fall 2025.
- Have a definite interest in pursuing a career in the beef industry.
- Are willing to learn, grow and be an advocate on behalf of the beef industry.
- Interested in devoting two days of long hours to meeting industry leaders and gaining a wealth of knowledge pertaining to the Texas and U.S. beef industry.
- Must be approved by a selection process that will include evaluation of a written application, short video and two letters of recommendation.
- Applicants must be willing to conduct themselves in a professional manner and abide by the code of conduct of the program. Applicants must be willing to accept consequences of misbehavior, including being sent home at any point during camp duration.
- Selected participants will be required to participate the entire tour time without exception.
- Selected participants and their parents will be required to sign a liability release waiver prior to program attendance.

#### Cost

A \$150 fee will be required for each attendee, paid upon acceptance to participate. Do not send fee with application. All other expenses, except for transportation to and from camp, will be assumed by TSCRA. Participants may want some money for personal spending.

### **Cattle Raisers Roundup Information**

TSCRA Cattle Raisers Roundup is a progressive, thought-provoking week, full of activities, tours and networking featuring all aspects of beef production from pasture-to-plate. Attendees will have the opportunity to visit with industry leaders, tour cattle operations and beef packing plants, and gain professional development skills. The program is intended for young leaders who are interested in gaining in-depth beef industry knowledge. Applicants not selected are encouraged, if age applicable, to reapply.

#### **Objectives**

- Introduce participants to all aspects of the beef industry including cow-calf, stocker, packer, retailer and consumer perspectives.
- Establish ideas for conservation, sustainability and stewardship of natural resources through rangeland stewardship.
- Build cognitive thinking skills through problem solving and leadership activities.
- Allow participants to meet and interact with leading industry representatives and TSCRA board and committee members.
- Create a networking opportunity of likeminded young leaders in the beef industry.

#### Criteria

- Individuals will be starting their junior or senior year of high school in fall 2025.
- Have a definite interest in pursuing a career in the beef industry.
- Are willing to learn, grow and be an advocate on behalf of the beef industry.
- Interested in devoting five days of long hours to meeting industry leaders and gaining a wealth of knowledge pertaining to the Texas and U.S. beef industry.
- Must be approved by a selection process that will include evaluation of a written application, short video and two letters of recommendation.
- If accepted, participants will be required to complete online Beef Quality Assurance (BQA) training before arriving for camp.
- Applicants must be willing to conduct themselves in a professional manner and abide by the code of conduct of the program. Applicants must be willing to accept consequences of misbehavior, including being sent home at any point during camp duration.
- Selected participants will be required to participate the entire tour time without exception.
- Selected participants and their parents will be required to sign a liability release waiver prior to camp attendance.

A \$250 fee will be required for each participant, paid upon acceptance to participate. Do not send fee with application. All other expenses, except for transportation to and from camp, will be assumed by TSCRA. Participants may want some money for personal spending.
